Information to Be Collected and Used	Name, sex, date of birth, nationality, telephone number, email address, address (home country), academic background, job career, certificates and training history, social and other activities, language skills, letter of self-introduction, and the purpose of sojourn
Period of Retention and Use	
<p>The personal information defined above shall be retained and used for the intended purpose only <u>from the date of consent to the collection and use of personal information to the 2 months from the completion of the last payment of living and other expenses</u> (information of unselected applicants will be immediately destroyed upon the end of the selecting process).</p> <p>After the last payment of living and other expenses is completed, such personal information shall be retained and used for the only purpose of investigating accidents, resolving disputes, treating complaints, and performing legal duties.</p>	
Right to Refuse to Consent and Consequences of the Refusal	
Applicants have a right to refuse to consent to the collection and use of personal information above. But the consent to collection and use of personal information is required in the course of the Scholarship Program and selection process, only applicants who consent to the collection and use shall be eligible to be selected as candidates for the Program.

Period of Retention and Use

Right to Refuse to Consent and Consequences of the Refusal	
Recommenders and guarantors have a right to refuse to consent to the collection and use of personal information above. But only when the recommender and guarantor consent to the collection and use of personal information can they provide legitimate recommendation and guarantee, and the applicants who receive such recommendation and guarantee from the such qualified individual shall be eligible to be selected as beneficiaries for the Scholarship Program.
