

# NACF Global Korea Scholarship Program

## ■ Overview

### ○ No. of Beneficiary (prerequisite)

1 (who is recommended by an ICAO member organization)

### ○ Study Period

Feb. 2023 – Feb 2027 (4 years in total)\*

- Korean Language School (1 year) → College Education (3 years)
- If the selected beneficiary has already acquired TOPIK (Test of Proficiency in Korean) Level 3, s/he can skip the Korean language course (in this case, study period will be 3 years in total)

### ○ Educational Institute

< Korean Language : 1 year >

Korea University Korean Language Center(KLC) or Yonsei University Korean Language Institute (KLI)

< College Education : 3 years >

Agricultural Cooperative University(ACU\*)

※ **ACU** : The beneficiary will major in Cooperative Digital Management and take both theoretical (related to management, economy, taxation, agriculture, finance, and digital) and field education.

## ■ Qualifications

The selected beneficiary must submit the certificates and documents s/he certifies in the application materials.

### ○ Age

19 to 25

### ○ Education Level

High school diploma (authorized by the government) or equivalent or above

### ○ Recommendation & Guarantee

Recommended and guaranteed by the head of an ICAO member organization

### ○ Language Skills

Fluency in Korean or English is preferred

### ○ Health Condition

Meet the criteria of a medical checkup

## ■ Financial Support

- Admission Fee, tuition, expenses for learning materials, and other necessary expenses for studying
- Expenses for housing; food (KRW 600,000/month); living (KRW 500,000/month); and premium of medical insurance
- Flight tickets for admission and graduation; and for visiting home (once a year)

## ■ Program Timeline

<b>Dec. 2022</b>	□ Preparation for entering Korea (ex. enrollment in a Korean language school, visa issuance, etc.)
<b>Feb. 2023</b>	□ Enter Korea and get into a language school
<b>Mar. 2024</b>	□ Get into ACU
<b>Feb. 2027</b>	□ End the study abroad program

## ■ Responsibilities

### ○ NACF

---

- 1) Plan for the study abroad program
- 2) Select and manage the beneficiary
- 3) Provide financial support

### ○ Recommending Organization

---

- 1) Recommend & Guarantee applicants
- 2) Help the applicants fill in application materials

### ○ Beneficiary

---

- 1) Study
- 2) Promote the NACF scholarship program (posts on SNSs or blogging)\*  
※ Promoting what the beneficiary experiences or learns at school, agricultural fields, exhibitions, etc.

## ■ Notes

### ○ Beneficiary

---

If the beneficiary fails to acquire TOPIK Level 3 one year after studying at the language school or fails to meet the graduation requirement of ACU, s/he shall reimburse her/his tuition in part and return to her/his home country.

### ○ Recommending Organization

---

Offer the beneficiary a job in the organization after graduation

### ○ ETC

---

Based on the above, an MOU between NACF, Recommending Organization, and the beneficiary will be signed.
